



All guests are advised that the Municipality of Giovinazzo has established, with the City Council Resolution No. 67 of 28/11/2023, the tourist tax pursuant to art. 4, Legislative Decree 23/2011.

It is applied for overnight stays during the entire solar year.

In case of rejection to pay this tax, the tourist must undersign a declaration.

## INFORMATION ABOUT THE TOURIST TAX

The Tourist Tax is payable by all non-residents who stay overnight at any accommodation facility in the territory of the Municipality of Giovinazzo (BA).

This tax is due for overnight stays during the entire calendar year within the limit of 3 consecutive nights (even when the stay is carried out at two or more accommodation facilities).

**Period of application: 1st January-31st December.**

### ESENZIONI

- Residents in the municipality of Giovinazzo;
- Minors until the fourteenth year of age;
- Persons (maximum no. 1) assisting patients admitted to health facilities in the territory of the ALS of Bari province;
- Member of State and local police, the other armed forces, and the National Fire Brigades who are on duty. Volunteers staying in case of emergency for disasters;
- Persons who stay in the accommodation facilities only for institutional, tourist and social purposes of the Municipality of Giovinazzo;
- Events organized by the municipal, provincial and regional administration or for environmental emergencies;
- Coach drivers and tour leaders providing assistance to organised groups. For the purposes of this exemption, an organised group is defined as a group of at least 20 persons with travel organised by means of a package tour arranged by a professional organiser with a single booking;
- Disabled persons (beneficiaries of the attendance allowance) and one accompanying person;
- Persons undergoing dialysis in health facilities in the territory of the ALS of the province of Bari;
- Persons over 70 years of age (from the day they turn 70).
